NOTICE OF EXTENSION OF THE PERIOD FOR COMPLIANCE WITH THE REGULATIONS FOR THE PROTECTION OF THE KAROO CENTRAL ASTRONOMY ADVANTAGE AREAS.

On 11 October 2019, I, Dr. Bonginkosi Emmanuel Nzimande, Minister of Higher Education, Science and Technology, extended the period of compliance with the Regulations for the Protection of the Karoo Central Astronomy Advantage Areas, in Government Gazette No. 42762, under Notice No. 1318.

Due to the restrictions imposed in terms of the Regulations made in terms of the Disaster Management Act, 2002 (Act No. 57 of 2002), as a result of the Covid-19 (Corona Virus) pandemic, I hereby further extend the period of compliance with the Regulations for the Protection of the Karoo Central Astronomy Advantage Areas by six (6) months in terms of Regulation 6 of Schedule A of the Regulations, to allow licencees and licence exempt operators more time to comply with the provisions of the said Regulations. The current due date for compliance with Regulation 3(2) of Schedule A Regulations which is 15 June 2020, is hereby extended by six (6) months and the new due date is now 15 December 2020.

KENNISGEWING VIR DIE VERLENGING VAN DIE TYDPERK VIR VOLDOENING AAN DIE REGULASIES VIR DIE BESKERMING VAN DIE KAROO SENTRALE ASTRONOMIEVOORDEELGEBIEDE.

Op 11 Oktober 2019 het ek, Dr. Bonginkosi Emmanuel Nzimande, Minister van Hoër Onderwys, Wetenskap and Tegnologie die periode om te voldoen aan die Regulasies vir die Beskerming van die Karoo Sentrale Astronomievoordeelgebiede, soos gepubliseer in die Staatskoerant Nr. 42762, onder Kennisgewing Nr. 1318, verleng.

As gevolg van die Covid-19 (Corona Virus) pandemie en die daaropvolgende beperkings wat die Regulasies in terme van die Wet op Rampbestuur, 2002 (Wet 57 van 2002) het op daaglikse lewens, verleng ek die periode om te voldoen aan die Regulasies vir die beskerming van die Karoo Sentrale Astronomievoordeelgebiede met 'n verdere ses (6) maande in gevolge Regulasie 6 van Skedule A van die Regulasies, om aan lisensiehouers en lisenisie vrygestelde operateurs meer tyd te gun om te voldoen aan die Regulasies. Die datum om te voldoen aan Regulasie 3(2) van Skedule A word verleng met 'n verdere ses (6) maande dus van 15 Junie 2020 tot 15 Desember 2020.
